Baker & McKenzie advises Conergy on the 25 MW Ichinoseki Solar Power 1 GK (ISP1) project in Iwate, Japan

Tokyo, June 2, 2016 – Baker & McKenzie has advised Conergy Japan K.K., the Japanese subsidiary of Conergy, one of the world's largest downstream solar companies, on the acquisition, development, sale and conclusion of EPC contracts for the construction of the 25.88 megawatt (MW) Ichinoseki photovoltaic mega solar power plant in Iwate Prefecture, Japan.

The project was initially acquired by Conergy Japan in 2014 and was developed to a construction ready stage by Conergy following such acquisition. The project company, Ichinoseki Solar Power 1 GK (ISP1) was then sold to a consortium of Global Power Synergy Public Company Limited (GPSC), Thailand's PTT Group's power flagship and Girana Anuman-Rajadhon in 2015. EPC contracts for Conergy Japan to supply solar components for the project and to lead the project construction were executed in April 2016 and the construction period is now underway.

Project construction will be financed by Shinsei Bank, Limited with commercial operation scheduled to commence in the fourth quarter of 2017. The project will supply power to Tohoku Electric Power under Japan's Feed-in Tariff scheme under a PPA at the rate of 40 yen per kWh for 20 years.
